## The Drinker Paradox

The *Drinker Paradox* is a principle of classical predicate logic popularised by the logician Raymond Smullyan in his 1978 book *What Is the Name of this Book?* which can be stated as:

There is someone in the pub such that, if he is drinking then everyone in the pub is drinking.

We can formalize and prove this assertion in Naproche:

**Signature.** A person is a notion.

**Signature.** Let  $P$  be a person.  $P$  is drinking is an atom.

**Signature.** The pub is an object.

**Signature.** Let  $P$  be a person and  $A$  be an object.  $P$  is inside  $A$  is a relation.

**Theorem.** Assume that there is a person inside the pub. Then there is a person  $P$  such that  $P$  is inside the pub and if  $P$  is drinking then every person inside the pub is drinking.

*Proof by case analysis.* Case every person inside the pub is drinking. Choose a person  $P$  inside the pub. Then  $P$  is drinking and every person inside the pub is drinking. Hence if  $P$  is drinking then every person inside the pub is drinking. End.

Case there is a person that is inside the pub and not drinking. Consider a person  $P$  that is inside the pub and not drinking. Then if  $P$  is drinking then every person inside the pub is drinking. End.  $\square$

## Russell's Paradox

*Russell's Paradox* is a set-theoretical paradox discovered by Bertrand Russell in 1901 which shows that every set theory with an unrestricted comprehension principle leads to contradictions. Using Naproche's ontology of classes and sets and its inbuilt axiom of class comprehension we can formalize this paradox as follows.

**Theorem.** There exists a class that is not a set.

*Proof.* Define  $R = \{x \mid x \text{ is a set such that } x \notin x\}$ . Assume that  $R$  is a set. Then  $R \in R$  iff  $R \notin R$ . Contradiction.  $\square$

## The Barber Paradox

The *Barber Paradox* is a puzzle illustrating Russell's Paradox, formulated by Bertrand Russell in 1918 with the following words:

You can define the barber as "one who shaves all those, and those only, who do not shave themselves". The question is, does the barber shave himself?

We can show in Naproche that the existence of such a barber would be contradictory.

**Signature.** A barber is a person.

**Signature.** Let  $B, P$  be persons.  $B$  shaves  $P$  is an atom.

Let  $P$  shaves himself stand for  $P$  shaves  $P$ .

**Theorem.** Let  $B$  be a barber such that for any person  $P$   $B$  shaves  $P$  iff  $P$  does not shave himself. Then we have a contradiction.

*Proof.*  $B$  shaves himself iff  $B$  does not shave himself.  $\square$

## Burali-Forti's Paradox

*Burali-Forti's paradox*, named after Cesare Burali-Forti, demonstrates that the assumption of the collection **Ord** of all all ordinal numbers being a set leads to contradictions.

**Theorem.**  $\mathbf{Ord}$  is not a set.

*Proof by contradiction.* Assume that  $\mathbf{Ord}$  is a set.  $\mathbf{Ord}$  is transitive and every element of  $\mathbf{Ord}$  is transitive. Hence  $\mathbf{Ord}$  is an ordinal. Thus  $\mathbf{Ord} \in \mathbf{Ord}$ . Contradiction.  $\square$

## Cantor's Paradoxes

Similar to Burali-Forti's Paradox, *Cantor's First Paradox*, discovered by Georg Cantor in 1897, states that the collection of all cardinal numbers cannot be a set.

**Theorem.** Let  $C$  be the collection of all cardinals.  $C$  is not a set.

*Proof.* Assume the contrary. Then  $\bigcup C$  is a set.

Let us show that  $\bigcup C$  contains every ordinal. Let  $\alpha$  be an ordinal. Choose a cardinal  $\kappa$  greater than  $\alpha$ . Then  $\alpha \in \kappa \in C$ . Hence  $\alpha \in \bigcup C$ . End.

Therefore  $\mathbf{Ord} \subseteq \bigcup C$ . Thus  $\mathbf{Ord}$  is a set. Contradiction.  $\square$

*Cantor's Second Paradox* denotes the observation that the collection of all sets cannot be a set itself. It was shown by Cantor in 1899 via his famous theorem stating that the cardinality of any set is strictly smaller than the cardinality of its powerset.

**Theorem.** Let  $V$  be the collection of all sets.  $V$  is not a set.

*Proof.* Assume the contrary. Then  $\mathcal{P}(V)$  is a set. Hence  $\mathcal{P}(V)$  is a subset of  $V$ . Thus  $|\mathcal{P}(V)| \leq |V|$ . Contradiction. Indeed  $|x| < |\mathcal{P}(x)|$  for any set  $x$ .  $\square$
